What is Crowdfunding Creativity?

Run by Creative Scotland in partnership with Paved With Gold, Crowdfunding Creativity is a pilot mentoring and match-funding scheme for those looking to embark on a crowdfunding campaign. It aims to provide people who are working in the creative industries in Scotland with the skills and knowledge to develop their own successful crowdfunding campaigns.

Over the course of the programme those selected to take part will learn not only how to develop their crowdfunding campaign but also gain key skills to help them support their creative practice. We are looking to select up to seven projects for the pilot, allowing us to focus on making each one a success.

Successful applicants will benefit from a programme of support including workshops and one-to-one sessions that complement key milestones through their project. In addition, they'll be able to access up to 25% match funding from Creative Scotland for their crowdfunding campaign.

Dè tha ann an Sluagh-mhaoineachadh Cruthachalachd?

Air a stiùireadh le Alba Chruthachail ann an com-pàirteachas le Paved With Gold, 's e sgeama pileat oideachais agus maoineachadh co-ionann a tha ann an Sluagh-mhaoineachadh Cruthachalachd dhaibhsan a tha ag iarraidh iomairt maoineachadh-sluaigh a thòiseachadh. Tha e ag amas air leigeil le daoine a tha ag obair anns na gnìomhachasan cruthachail ann an Alba agus aig a bheil na sgilean agus an t-eòlas gus na h-iomairtean soirbheachail maoineachadh-sluaigh aca fhèin a chur an sàs.

Thairis air ùine a' phrògram bidh an fheadhainn a tha air an taghadh gus pàirt a ghabhail ann ag ionnsachadh mar a chuireas iad an iomairt maoineachadh-sluaigh aca fhèin air dòigh agus cuideachd ionnsaichidh iad sgilean cudromach gus taic a chur ris na gnìomhan cruthachail aca. Tha sinn ag iarraidh suas ri seachd pròiseactan a thaghadh airson a' phìleat, a' leigeil leinn fòcas a chur air a h-uile gin dhiubh gus dèanamh cinnteach gum bi iad uile soirbheachail.

Gheibh tagraichean a tha soirbheachail buannachd bho phrògram taic anns a bheil rudan leithid bùithean-obrach agus seiseanan fa leth a tha a' cur ri prìomh chomharrachaidhean tron phròiseact aca. A bharrachd air sin, thèid aca air suas ri 25% de mhaoineachadh co-ionann fhaighinn bho Alba Chruthachail airson an iomairt maoineachadh-sluaigh.

What is behind this pilot project?

Increasingly, individuals and businesses are looking to crowdfunding as a means to support product launches and the development of new ideas. For smaller creators, crowdfunding can be the difference between a project happening or not. As competition for funding increases and available funds are spread more thinly, crowdfunding is becoming a viable way to generate the early-days financial boost that projects need to get up and running.

The programme builds on work carried out by the Creative Industries team during 2017 in exploring alternative sources of finance for creative practitioners and businesses.

Following the **Access to Finance: More Than Money** event delivered in partnership with Creative Edinburgh, Creative Scotland worked with Kaye Symington from Paved With Gold to prepare and share knowledge and understanding about the potential of crowdfunding within Scotland's creative communities. The result of this work was The Next Generation of Crowdfunding Report, which we have recently published [on our website](#).

Dè tha air cùlaibh a' phròiseact pileat seo?

Tha e a' sìor fhàs nas bitheanta gu bheil daoine fa leth agus gnothachasan a' coimhead air maoinachadh-sluaigh mar dhòigh air stuthan ùra a chur air bhog agus gus beachd-smuaintean ùra a chruthachadh. Do luchd-cruthachaidh nas lugha, faodaidh maoinachadh-sluaigh an diofar a dhèanamh eadar an tachair pròiseact no nach tachair. Mar a tha barrachd farpaiseachd ann airson maoinachadh agus gu bheil na tha de dh'airgead ri fhaighinn air a roinn nas taine, tha maoinachadh-sluaigh air a dhol na dhòigh a ghabhas taic ionmhasail a thoirt do phròiseact aig ìre thràth gus a cur gu dol.

Tha am prògram a' togail air an obair a chaidh a dhèanamh le sgioba nan Gnìomhachasan Cruthachail ann an 2017 ann a bhith a' feòrachadh tùsan ionmhais de luchd-cruthachaidh agus do ghnòthachasan.

An dèidh an tachartais Inntigeadh **Ionmhais: Barrachd air Airgead** ann an com-pàirteachas ri Dùn Èideann Chruthachail, dh'obraich Alba Chruthachail le Kaye Symington bho Paved With Gold gus eòlas agus tuigse ullachadh agus a roinn air na cothroman an cois maoinachadh-sluaigh taobh a-staigh nan coimhearsnachdan cruthachail ann an Alba. B' e buil na h-obrach seo an aithis air An Ath-ghinealach de Mhaoineachadh-sluaigh, a tha sinn air a chur air an làraich-lìn [againn bho chionn ghoirid](#).

Who are Paved With Gold?

Paved With Gold is an agency that specialises in launching and building community-centric brands. They work closely with passionate designers, makers and do-ers who have great ideas they want to bring to life and grow. They are experts in delivering successful crowdfunding campaigns and to date have helped projects raise over £1.1m on Kickstarter. They are also endorsed by Kickstarter as crowdfunding experts.

If selected, what support do you receive?

If you are accepted onto the programme you will be invited to take part in a bespoke series of workshops and will benefit from one-to-one mentoring to help you develop your crowdfunding campaign. Once you have raised the first 75% of your budget via crowdfunding you will then receive match funding of up to 25% for your total project costs from Creative Scotland.

The minimum total crowdfunding target is £750 which would result in an award of up to £250 from Creative Scotland. The maximum cash award given out by Creative Scotland will be £5,000. We are looking to support a minimum of 5 projects and a maximum of 7 projects.

Cò iad Paved With Gold?

'S e buidheann a tha ann am Paved With Gold a bhios gu sònraichte a' cur air bhog agus a' togail branndan le sealladh coimhearsnachd. Bidh iad ag obair gu dlùth le dealbhadairan dealasach, feadhainn a bhios a' dèanamh agus a' cruthachadh agus aig a bheil deagh bheachd-smuaintean a tha iad ag iarraidh a thoirt gu bith agus fhàs. Tha iad nan sàr-eòlaichean air a bhith a' libhrigeadh iomairtean maoineachadh-sluaigh soirbheachail agus gu ruige seo tha iad air còrr agus £1.1m a thional air Kickstarter. Tha iad cuideachd air cùl-taic fhaighinn bho Kickstarter mar shàr-eòlaichean air maoineachadh-sluaigh.

Ma thèid do thaghadh, dè an taic a gheibh thu?

Ma thèid gabhail riut air a' phrògram gheibh thu cuireadh pàirt a ghabhail ann an sreath shònraichte de bhùithean-obrach agus gheibhear buannachd bho sgeama oideachaidh fa leth gus do chuideachadh ann a bhith a' leasachadh d' iomairt maoineachadh-sluaigh. Aon uair 's gu bheil thu air a' chiad 75% den bhuidseat agad a thional tro mhaoineachadh-sluaigh gheibh thu an uair sin maoineachadh co-ionann de suas ri 25% de chosgais iomlan na pròiseact agad bho Alba Chruthachail.

'S e £750 an targaid iomlan as ìsle airson maoineachadh-sluaigh agus gheibheadh seo tabhartas de suas ri £250 bho Alba Chruthachail. 'S e £5,000 an tabhartas as motha a bheir Alba Chruthachail seachad. Tha sinn an dùil taic a thoirt ri còig pròiseactan aig a' char as lugha agus 7 aig a' char as motha.

Who can apply?

This opportunity is open to creative individuals and businesses based in Scotland and working in the arts, screen and creative industries and who are looking to embark on a crowdfunding campaign. We are looking for applicants with limited or no previous experience of crowdfunding:

- **Individuals** — this includes, but is not restricted to, individual artists and creative practitioners who are writers, musicians, craft makers, fashion designers, dancers, visual artists, producers, curators, digital artists or those working in film, theatre, publishing or any of the creative industries.¹
- **Groups or Collaborations** — unconstituted creative groups such as bands, ensembles or any partnerships where two or more people usually work together on projects are eligible. Additionally, individuals can apply jointly, on an artistic collaboration for example, but one applicant will have to take the lead and assume responsibility for managing the application and any finance awarded.
- **Creative businesses** — you can apply to participate if you're a creative business based in Scotland and your work or project is related to any of the arts, screen or creative industries. In the application you'll be asked to tell us what type of creative business you are.

Who can apply?

Tha an cothrom seo fosgailte do luchd-cruthachalachd fa leth agus do ghnòthachasan a tha stèidhte ann an Alba agus a tha ag obair anns na h-ealainean, sgrìon agus gnìomhachasan cruthachail agus a tha ag iarraidh iomairt maoineachadh-sluaigh a thòiseachadh. Tha sinn a' sireadh thagraichean aig nach eil mòran eòlais no aig nach eil eòlas sam bith a thaobh maoineachadh-sluaigh a-cheana:

- **Daoine fa leth** — tha seo a' gabhail a-steach, ach chan eil e a' cuingealaichte ri, luchd-ealain agus luchd-cruthachalachd fa leth a tha nan sgrìobhaichean, luchd-ciùil, luchd-ciùird, dealbhadairean fasain, dannsairean, luchd-ealain lèirsinneach, riochdairean, luchd-cùraim, luchd-ealain didseatach no iadsan a tha ag obair ann am film, theàtar, foillseachadh no ann an gnìomhachasan cruthachail sam bith.¹
- **Buidhnean no Co-obrachaidhean** — tha e fosgailte do bhuidhnean cruthachail nach eil comh-shuidhichte leithid còmhlain-ciùil, buidhnean no com-pàirteachasan de dhithis no barrachd a bhios ag obair còmhla air pròiseactan. Cuideachd, faodaidh daine fa leth cur a-steach air a shon mar phàirt de cho-obrachadh ealain mar eisimpleir, ach feumaidh aon tagraiche a bhith os cionn gnothaich agus feumaidh e/i a bhith an urra ri bhith a' stiùireadh an tagraidh agus a' gabhail uallach airson maoineachadh sam bith a gheibhear.
- **Gnòthachasan cruthachail** — faodaidh tu cur a-steach air a shon ma 's e gnòthachas cruthachail a th' annad a tha stèidhte ann an Alba agus ma tha do chuid obrach no pròiseact a' buntainn ri gin de na gnìomhachasan ealain, sgrìon no cruthachail. Anns an tagradh, thèid iarraidh ort innse dhuinn dè an seòrsa gnòthachas cruthachail a tha annad.

Who can't apply

- **Creative Scotland Regularly Funded Organisations.**
- **Students** Creative Scotland does not support current students for their studies, or for any funding related to any full time, long term, formal or accredited programmes of education in the UK or abroad (this includes both tuition fees and/or any living costs for the student whilst on their course, and also includes funding for any artistic or creative work, whether or not it is related to your studies). You can therefore only apply once you have fully completed your studies.
- **Individuals working in sectors outside the arts, screen and creative industries** and seeking funding for non-artistic or non-creative activity (this includes sectors like tourism, sports, and the museums and heritage sector).
- **Academic bodies (Schools, FE Colleges and/or HE Institutions).**
- **Academics or other education professionals** seeking funding related to their educational role.
- **Applicants based outside Scotland.**
- **Projects which have already begun crowdfunding before the programme is set to begin in September 2018.**

Cò nach fhaod tagradh a chur?

- **Buidhnean le Maoineachadh Cunbhalach bho Alba Chruthachail.**
- **Oileanaich** Chan eil Alba Chruthachail a' cur taic ri feadhainn a tha nan oileanaich an-dràsta len cuid chùrsaichean, no le maoineachadh sam bith co-cheangailte ri prògraman foghlaim làn-ùine, fad-ùine, foirmeil no le teisteanas anns an RA no thall thairis (agus tha sin a' gabhail a-steach chùisean teagaisg agus/no cosgaisean bith-beò dhan oileanach fhad 's a tha iad air a' chùrsa aca, agus tha e cuideachd a' gabhail a-steach maoineachadh airson obair ealain no cruthachail, ged a bhiodh no nach biodh e a' buntainn ris na cùrsaichean aca). Mar sin, faodaidh tu tagradh a chur a-steach an dèidh dhut crìoch a chur air a' chùrsa.
- **Daoine fa leth a tha ag obair ann an roinnean taobh a-muigh nan ealainean, sgrìon agus gnìomhachasan cruthachail** agus a tha a' sireadh maoineachadh airson gnìomhan neo-ealaineach no neo-chruthachail (tha seo a' gabhail a-steach roinnean leithid turasachd, spòrs, agus roinn nan taighean-tasgaidh agus dualchais).
- **Buidhnean acaideamaigeach (Sgoiltean, Colaistean FA agus/no Ionadan Foghlam Àrd-ìre).**

Programme criteria

To give those taking part the best chance of success as part of this programme, we will be looking for applicants to meet the following criteria:

KEY REQUIREMENTS

Project

- A fully formed idea that only requires funding to make a start and has not already begun.
- A project which is achievable by the creator within the timeframe of the programme.
- A compelling reason for their project to exist, and something that people can get behind.

Budget

- A good understanding of the total project budget aligned with a reachable crowdfunding goal.

Skills and capacity

- The applicant (and their project team, if applicable) has capacity to create and implement a crowdfunding campaign, including promoting, writing copy, creating a video and taking photography.

Time

- Applicants must be available for all programme workshop sessions taking place in September and October 2018.
- Applicants should be able to launch their crowdfunding campaigns between October 2018 and no later than 15 February 2019. (Please note - launching outwith these dates will result in the loss of the Creative Scotland 25% match funding support)

Slatan-tomhais a' phrògraim

Gus an cothrom as fheàrr as urrainn a thoirt dhaibhsan a tha an sàs anns a' phrògram seo a bhith soirbheachail, bidh sinn a' coimhead air tagraichean a choileanas na slatan-tomhais a leanas:

PRÌOMH RIATANASAN

Pròiseact

- Beachd-smuain a tha ullaichte aig nach eil feum ach air maoinachadh gus tòiseachadh agus nach eil air tòiseachadh mu thràth.
- Pròiseact as urrainn dhan neach-cruthachaidh a dhèanamh taobh a-staigh frèam-obrach a' phrògraim.
- Adhbhar làidir dhan phròiseact aca tighinn beò, agus rudeigin ris an urrainn do dhaoine taic a chur.

Buidseat

Ùine

- Feumaidh tagraichean a bhith air chomas a dhol chun a h-uile gin de na seiseanan bùithean-obrach a tha mar phàirt den phrògram anns an t-Sultain agus san Dàmhair 2018.
- Bu chòir do thagraichean a bhith air chomas an iomairtean maoinachadh-sluaigh a chur air bhog eadar an Dàmhar 2018 agus ro 15 den Ghearran 2019 air a' char as fhaide. (Thoir an aire - ma thèid cur air bhog taobh a-muigh nan cinn-latha sin, caillear taic an 25% de mhaoineachadh co-ionann bho Alba Chruthachail)

Other things we will consider in determining the possible success of your campaign:

Rewards

- Ideas for crowdfunding rewards that can feasibly be delivered by the creator.

Community

- An existing following (ideally online) who would be interested in supporting the project.
- A strong personal network of friends, family and experts/influencers who could help endorse and support your project.

Story

- An association with other relevant communities or organisations.
- Relevant awards or notable previous projects.

Creative

- Skills and experience to help with video production, photography and design.

Duaisean

- Beachd-smuaintean airson duaisean maoinachadh-sluaigh as urrainn a bhith air an solarachadh leis an neach-cruthachaidh.

Coimhearsnachd

- Luchd-leantainn stèidhichte (na b' fheàrr air-loidhne) aig am biodh ùidh ann a bhith a' cur taic ris a' phròiseact.
- Lìonra làidir de charaidean, teaghlach agus eòlaichean/luchd-buaidh a dh'fhaodadh taic agus cuideachadh a thoirt dhan pròiseact agad.

Sgeulachd

- Ceangal ri coimhearsnachdan no buidhnean iomchaidh eile.

Workshop Breakdown

Three group workshops are planned, allowing us to bring together all the projects and Creative Scotland officers working on the programme. These have been kept to a minimum in order to reduce travelling and time away for attendees. Sessions will be held in the most appropriate locations for the attendees, ensuring that they can be as accessible as possible. To support each applicant/project through their campaign we recommend regular one-to-one catch ups throughout the pilot to move them through each milestone. These catch ups will be delivered via phone/skype or email to allow for maximum flexibility.

Sharing your experiences

Sharing is an essential component of Crowdfunding Creativity and all applicants must be prepared to share their experiences with the other participants. You may also be asked to share your experiences via Creative Scotland channels at a future date.

Application requirements

For applications to be eligible:

- It is essential that you provide links to any previous examples of work you wish to be considered as part of your application. All supporting documentation must be submitted at the time of application. Please ensure that the application form makes clear where you have attached supporting material or provided a link to it.
- The budget information in the application form and the submitted budget must balance. For organisations: you must provide a copy of your constitutional documents and Equal Opportunities Policy.
- For sole traders: you must provide your Unique Tax Reference Number at the time of submission.
- You must both complete the budget summary section in the application form and provide a more detailed budget attachment. See the next section for more details.
- You must check or tick the disclaimer box on the application form to confirm that they have read and understood the Guidelines and standard Terms and Conditions.

A' co-roinn na dh'fhiosraich thu

Tha co-roinn na phàirt dheatamach de Shluagh-mhaoineachadh Cruthachalachd agus feumaidh gach tagraiche a bhith deiseil a bhith a' co-roinn na dh'fhiosraich iad leis na com-pàirtichean eile. Dh'fhaodte gun tèid iarraidh ort an t-eòlas a fhuair thu a cho-roinn tro sheanailean Alba Chruthachail san àm ri teachd.

Riatanasan airson Thagraidhean

Airson a bhith ion-roghnach, feumaidh tagraidhean a bhith mar a leanas:

- Feumaidh tu ceanglaichean a chur ann airson eisimpleirean de dh'obair a rinn thu roimhe ma 's e is gu bheil thu airson 's gun tèid beachdachadh orra mar phàirt den tagradh agad. Feumar na sgrìobhainnean taice uile a chur thugainn aig an aon àm ris an tagradh. Budget

In the application form you will be asked to outline how much match-funding you are applying for. You will therefore need to supply a provisional budget. In addition to the mandatory budget questions in the application form, you must also provide a separate spreadsheet to submit a more detailed budget. This should be submitted as an attachment to your application. You must still complete the budget summary section within the application form and both this and your attachment must be accurate and complete for your application to be considered eligible.

The budget information in the application form and the submitted budget must balance. When completing your budget please include all crowdfunding-related income and expenditure, any partnership income and, where applicable, any in-kind support. For in-kind support please include an approximate financial value. Please note that we are committed to ensuring that activities we fund are inclusive and accessible to a wide range of participants and therefore we encourage you to include relevant access costs. For example: British Sign Language interpretation; audio description and captioning; access assistants if required to support travel; or any costs relating to Gaelic/ Scots translation.

We would ask that you pay particularly close attention to the costs you allocate for paying the people involved in delivering your project. Creative Scotland is committed, through any activities we support, to ensure that artists, staff and other creative professionals are paid appropriately for their time and effort. We therefore expect applications to reference relevant industry standards on rates of remuneration where they exist.

Once a decision is made

Once we have reached a decision, we will write to you to let you know the outcome of your application. If you are successful, we will send you further details on the programme and will issue you with a Funding Agreement. You must note and adhere to all the **terms and conditions** of the Funding Agreement.
